Thank you for your kind note and letter from last week. It is a pleasure to meet you over email.

We appreciate the overview you shared and excitement to connect. As we noted in our letter following the last IOC EB meeting at the beginning of April, we are in close collaboration with the IOC outlining our approach to finalize the LA28 Sport Programme over the course of the next year. To be consistent across all Federations we have not had any presentations or requested information from any IF at this time.

The next step in our process later this month is for the Olympic Programme Commission and IOC Executive Board to review and approve the assessment criteria that we will collaboratively use to review both the disciplines within the initial sport programme, as well as utilize for any potential new sports assessment. This criteria will be aligned to the Principles that were validated and shared at the beginning of April. Our intention will be to communicate again to all IFs following the IOC EB meeting and next steps from there.
